**RULES & GUIDELINES REGARDING  
APPLICATION FOR  
CONTINUING EDUCATION & PROFESSIONAL DEVELOPMENT  
SCHOLARSHIPS**

Purpose:

To encourage active participation in the BBC of PAF and assist members in obtaining continuing education credits.

Rules:

1. Must be an active member in good standing of both BBC of PAF and PAF.
2. Members must have active participation in BBC of PAF activities including, but not limited to, attendance at monthly meetings, past attendance at BBC of PAF Seminars, committee membership and participation.
3. A member may not receive a scholarship two (2) years in a row.
4. Applications for the current year seminars must be submitted to the Education & Scholarship Chairman no later than:  
**March 5** for the BBC of PAF Spring Seminar;  
**April 15** for the PAF annual meeting/Spring Seminar; and,  
**August 15** for the PAF Fall Seminar;  
Reimbursements will apply to any fees and/or dues the Applicant has already paid. Proof of payment of fees (copy of a canceled check) must be submitted prior to reimbursement.
5. Applications received after the deadline will not be accepted.
6. Incomplete applications will not be considered.
7. The Education/Scholarship Committee shall judge the applications and make a recommendation to the Executive Committee of the BBC of PAF. Upon ratification by the Executive Committee, the Committee Chairperson shall contact the winner.
8. The winner's name may be published in any official publications of the BBC of PAF or PAF.
9. BBC of PAF reserves the right not to award a scholarship if there are no qualifying applications.
10. The decision of the BBC of PAF regarding the award of any scholarship is final.
